

Resolution 09-0618-11: Mrs. Reis moved to amend Exhibit A of Resolution 04-0520-07 regulating parking on all Township streets with exceptions where consideration of Public Safety permit as outlined below:

EXHIBIT A

No parking shall be permitted on either side of:
Voll Road, from northeast side of 1342 Voll Road for a distance of 37 feet
Voll Road, from northeast side of 1352 Voll Road for a distance of 49.5 feet

Vote: two yeas.

Resolution 09-0820-22: Mr. Jackson moved to amend Exhibit A of Resolution 04-0520-07 regulating parking on all Township streets with exceptions where considerations of public safety permit as outlined below:

No parking shall be permitted on either side of:

Lancelot Drive, from Hunterspoint Lane to Evanor Lane

Resolution 12-0315-07: Mr. Jackson moved to amend Exhibit A of Resolution 04-0520-07 regulating parking on all Township streets with exceptions where considerations of public safety permit as outlined below:

**No parking shall be permitted on the inside radius of the curve at 8521 Holiday Hills Drive.

Resolution 12-1115-04: Ms. Reis moved to amend Exhibit A of Resolution 04-0520-07, regulating parking on all Township streets with exceptions where consideration of Public Safety, by the addition of the following language requires:

No parking shall be permitted on the south side of Stirrup Road, along the frontage of 6465 and 6453.

Mr. O'Brien seconded the motion.

Motion to Amend Resolution No. 04-0520-07 Regulating Parking on All Township Streets –

Resolution 17-0622-07: Ms. Stone moved to amend Section a, and Exhibit A of Resolution 04-0520-07, Regulating Parking on all Township Streets with Exceptions where Consideration of Public Safety Permit as follows: Section a. shall read “the side of each Township street on which one or more fire hydrants is or are located (the “hydrant side”) with the exceptions of Northport, Stonegate, Woodcroft, and (as shall be determined by the Fire Chief) the widest portions of Markley Woods Way.” Exhibit A prohibiting parking on either side of particular streets shall be amended to include “Towne Center Way from Wolfangel Road to Five Mile Road”.
