RESOLUTION NO. 18-1220-12

RESOLUTION TO ADOPT 2010 SOUTHWEST OHIO FIRE SAFETY COUNCIL UNIFIED STANDARDS AND 2017 OHIO FIRE CODE

WHEREAS, Ohio Revised Code Section 505.373 ("Statute") permits a board of township trustees, by resolution, to adopt by incorporation by reference a standard code pertaining to fire, fire hazards, and fire prevention prepared and promulgated by, among others, the state or a public or private organization that publishes a model or standard code; and

WHEREAS, the Board of Township Trustees of Anderson Township ("Board") desires to adopt by incorporation by reference the Ohio Fire Code (2017 Edition) ("2017 Ohio Fire Code"), as the same may be amended from time to time; and

WHEREAS, this Board previously adopted the 2010 Southwest Ohio Fire Safety Council ("SWOFSC") Unified Fire Code; and

WHEREAS, this Board desires to replace the Ohio Fire Code (2011 Edition) previously adopted with the 2017 Ohio Fire Code, which will be utilized in conjunction with the 2010 Unified Fire Code of SWOFSC to which the Township adheres; and

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TOWNSHIP TRUSTEES OF ANDERSON TOWNSHIP, COUNTY OF HAMILTON, OHIO, that:

Section 1. The 2017 Ohio Fire Code, as the same may be amended from time to time, is hereby adopted by incorporation by reference, as permitted by the Statute.

Section 2. The 2010 Unified Standards A through J as promulgated by the SWOFSC to be used in conjunction with the 2017 Ohio Fire Code are hereby adopted by incorporation by reference, as permitted by the Statute.

- Section 3. The Ohio Fire Code (2011 Edition) previously adopted by this Board on April 19, 2012 is hereby repealed in its entirety.
- Section 4. The Fiscal Officer for Anderson Township is hereby directed to publish and post all notices as required by the Statute, and to maintain copies of the documents referenced in Sections 1 and 2 hereof for inspection by and distribution to the public, at cost.
- Section 5. In accordance with Ohio Revised Code Section 505.374, no person shall violate the 2017 Ohio Fire Code, as amended or the 2010 Unified Standards as adopted by this Board. In accordance with Ohio Revised Code Section 505.374, each day of continued violation of the 2017 Ohio Fire Code, as amended or the 2010 Unified Standards shall constitute a separate offense for which a penalty shall be imposed pursuant to Ohio Revised Code Section 505.99.
- Section 5. That this Board hereby finds and determines that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without implied limitation) Ohio Revised Code Section 121.22, except as otherwise permitted hereby.
