## Electricity Aggregation and Building Rate Information

Mr. Magna introduced Dan Deters with Energy Alliances. Mr. Magna and Mr. Deters updated the Board on rate increase timing and likelihood. They will make recommendations to the Board for action for both the Township owned properties as well as aggregation.

# Tree Maintenance Plan

## Bus Shelter for Mercy Anderson

## Senate Bill 56 Update

She also mentioned other instances that the state eliminated local funding or re-allocated it to the State. Mrs. Earhart gave the Board copies of testimony to be read at the hearing in Columbus the following week and asked for feedback. The Board discussed messaging, testimony phrasing, and the bill's economic impact to the Township.

The Board thanked Mrs. Earhart for all her work.
