RESOLUTION NO. 25 – 0626 – 01

RESOLUTION APPROVING AND ADOPTING THE 2026 TAX BUDGET AND AUTHORIZING ITS FILING WITH THE HAMILTON COUNTY BUDGET COMMISSION

WHEREAS, with limited exception, Ohio Revised Code Section 5705.28 requires that on or before the fifteenth day of July each year, the taxing authority of all subdivisions and taxing units other than school districts and the city of Cincinnati shall adopt a tax budget for the succeeding year; and

WHEREAS, Ohio Revised Code Section 5705.30 requires that at least two copies of the budget of each subdivision be filed in the office of the fiscal officer of the subdivision for public inspection not less than ten days before its adoption by the taxing authority and such taxing authority shall hold at least one public hearing thereon, of which public notice shall be given by at least one publication not less than ten days prior to the date of the hearing in the official publication of such subdivision, or in a newspaper of general circulation in the subdivision; and

WHEREAS, after its adoption, the budget shall be submitted to the county auditor on or before the twentieth day of July; and

NOW, THEREFORE, BE IT RESOLVED, by the Board of Township Trustees (the "Board") of Anderson Township, County of Hamilton, Ohio (the "Township"), as follows:

SECTION 1. That, a public hearing having been duly noticed and held, this Board hereby adopts the 2026 Tax Budget as presented by the Township Administrator and authorizes the Fiscal Officer to file the 2026 Tax Budget with the Hamilton County Budget Commission no later than July 20, 2025, as generally set forth in Attachment A hereto.

SECTION 2. That the preambles to this Resolution are deemed to be integral parts of this Resolution.

SECTION 3. That this Board hereby finds and determines that all formal actions of this Board concerning and relating to the passage of this Resolution were taken in open meeting of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without implied limitation) Ohio Revised Code Section 121.22, except as otherwise permitted hereby.

There was no further discussion.

PUBLIC FORUM

Mr. Cochran of 1466 Apple Farm Lane expressed concern regarding people riding bullet bikes in groups. He noted his concern about safety for residents because of speeding and the noise nuisance they create. He stated he is worried an injury will create a liability for the township.

Bruce Berno of 2156 Heather Hill Blvd. asked the Board to consider joining Green Umbrella. He presented the various initiatives and programs the group leads, its partnership with OKI, and stated they host the Midwest Regional Sustainability Summit.

TRUSTEE COMMENTS

Mrs. Stone wished the community a Happy July 4th and mentioned parade next week.

Mrs. Lausten said the parade is always an emotional event and thanked Mr. Sievers and staff for their work on it.

Mrs. Stone stated she is glad Mr. Cochran brought the bullet bike matter to the Board's attention.

Mr. Gerth asked Mrs. Earhart and Lt. Downing to address Mr. Cochran's concerns regarding the motorcycle nuisance.

Lt. Downing stated it would be a constitutional violation to target any specific group driving on a public roadway. He presented area traffic/crash data, specifically motorcycles on Salem. Additionally, he stated the primary issue is related to quality of life, acknowledged there is always risk with motorcycles, and that his first and foremost concern is public safety. He also acknowledged the noise is an annoyance.

Mrs. Lausten stated a continuous noise could be investigated, and that ability was limited in this case.

Mr. Gerth asked if there is an Ohio noise law. Lt. Downing stated the ORC has only a provision for working mufflers.

FISCAL OFFICER

Mr. Johnson stated there is a go-live date in September for the new accounting system.

RESOLUTION DETERMINING EXISTENCE OF NUISANCE ON LAND OWNED BY NATHAN J. ALLEN, LOCATED AT 6664 FOSTER AVENUE, IN ANDERSON TOWNSHIP, AND PROVIDING FOR NOTICE AND REMEDIATION PURSUANT TO OHIO REVISED CODE SECTION 505.87

Whereas, a board of township trustees may provide for the abatement, control, or removal of vegetation, garbage, refuse, and other debris from land in the township, if the board determines that the owner's maintenance of that vegetation, garbage, refuse, or other debris constitutes a nuisance, pursuant to Ohio Revised Code Section 505.87 (the "Statute");

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TOWNSHIP TRUSTEES (the "Board") OF ANDERSON TOWNSHIP, OHIO (the "Township"), that:

Section 1. Maintenance of the vegetation, garbage, refuse or other debris by the owner or owners (the "owner"), as specified in Schedule A hereto (which by this reference is incorporated herein), is hereby determined to constitute a nuisance within the meaning of the Statute and the owner is hereby ordered to abate, control, or remove the vegetation, garbage, refuse, or other debris as set forth herein.

Section 2. If the owner of the land upon which the nuisance is located is determined by the Anderson Township Planning & Zoning Department to be a resident of the Township or a nonresident whose address is known, the Planning & Zoning Department shall give notice to such owner, on behalf of this Board, in substantially the form attached hereto as Schedule A, by posting that notice in a sheltered place and/or in a waterproof envelope on the principal structure (if any) on such land and photographing the posted notice with a camera capable of recording the date of the photograph on it. Such notice shall also be sent, on behalf of this Board, by certified mail to the owner and to each lienholder of record. If such owner's address is unknown and cannot reasonably be obtained, the Zoning Inspector for the Township shall cause such notice to be published once in a newspaper of general circulation in the Township.

Section 3. If, within seven (7) days after the giving of the notice or notices provided for in Section 2 hereof, the owner of such land fails to abate, control, or remove the vegetation, garbage, refuse and/or debris, and no agreement is entered into with the Board under Ohio Revised Code Section 505.87(D) to provide for said abatement, control, or removal, then the Zoning Inspector, on behalf of this Board, shall provide for such abatement, control, or removal and, on behalf of this Board, may employ the necessary labor, materials, and equipment to perform the task. The expenses to be incurred in that regard are hereby authorized and appropriated to be paid from the Township General Fund from moneys not otherwise appropriated, and any cost incurred by the Board in performing that task shall be entered upon the tax duplicate and become a lien upon the land from the date of entry. Those expenses shall be recovered by the Township pursuant to Ohio Revised Code Section 505.87(F).

Section 4. This Board hereby finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements,

WHEREAS, the Township Trustees have manually signed each purchase order under present practices and they seek to facilitate a more expeditious process;

NOW, THEREFORE, BE IT RESOLVED by the Board of Township Trustees (the "Board") of Anderson Township, Hamilton County, Ohio (the "Township"), that:

SECTION 1. This Board hereby determines that it is in the best interest of the Township for this Board to delegate, and this Board does hereby delegate to and authorize, the Township Administrator, pursuant to subsection (G) of the Statute, to electronically authorize purchase orders for those expenditures for which funds have been appropriated either (a) in the Township's

RESOLUTION APPROVING SECOND AMENDMENT TO PARKING FACILITIES LICENSE AGREEMENT WITH ANDERSON INVESTORS OH, LLC AND AUTHORIZING ITS EXECUTION AND DELIVERY

WHEREAS, Anderson Investors OH, LLC, a Delaware limited liability company ("Anderson Investors"), is the fee owner of certain real property comprised of Hamilton County Auditor's Parcel Numbered 500-0202-0197-00 located at 7500 Beechmont Avenue, in Anderson Township (the "AI Property"), on which open parking spaces are located; and

WHEREAS, the AI Property is in close proximity to the former Anderson Center Station, and lies along existing METRO transit routes which provide service to the former Anderson Center Station; and

WHEREAS, Anderson Township, County of Hamilton, Ohio (the "Township"), secured public parking spaces and facilities for a METRO Park & Ride, during the redevelopment of the Anderson Center Station subject to the terms of that certain Parking Facilities License Agreement, effective November 1, 2021, by and between Anderson Township, acting by and through this Board, and Anderson Investors (the "Original Agreement"); and

WHEREAS, the Original Agreement was amended by that certain First Amendment to Parking Facilities License Agreement, effective the 5th day of September, 2023 (the "First Amendment"); and

WHEREAS, the Township and Anderson Investors desire to extend the term of the Original Agreement as amended by the First Amendment to December 31, 2025 and to enter into that certain Second Amendment to Parking Facilities License Agreement (the "Second Amendment" and together with the Original Agreement as amended by the First Amendment, the "Agreement") attached hereto as Exhibit A and by this reference incorporated herein;

NOW, THEREFORE, BE IT RESOLVED, by the Board of Township Trustees (the "Board") of Anderson Township, County of Hamilton, Ohio, as follows:

SECTION 1. This Board hereby determines that it is in the best interest of the Township to extend the term of the Original Agreement as amended by the First Amendment through December 31, 2025 (subject to earlier termination as provided in the Agreement) by entering into the Second Amendment to provide an alternative and temporary public Park & Ride facility during the continued redevelopment of the Anderson Center Station site on the terms and subject to the conditions contained in the Agreement.

SECTION 2. This Board hereby approves the form of the Second Amendment attached hereto as Exhibit A and hereby authorizes and directs the Township Administrator to execute and deliver the Second Amendment in substantially the form of Exhibit A, with such revisions thereto as she deems, after consultation with the Law Director, not to be disadvantageous to the Township, such determination being conclusively evidenced by her execution of the Second Amendment. This Board hereby authorizes performance of the Agreement and covenants to perform its obligations in accordance with the terms and conditions of the Agreement.

SECTION 3. The preambles to this resolution are and shall be for all purposes integral and operative parts of this resolution.

SECTION 4. This Board hereby finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without implied limitation) Ohio Revised Code Section 121.22, except as otherwise permitted thereby.
