Mrs. Stone thanked everyone for attending. And noted she wanted the Boards of all three agencies same page on what the comprehensive plan update.


Ms. Donovan thanked everyone for attending and introduced Abbie Emison and Jonathan Miller from McKenna.

It was also noted the plan will inventory community assets and resources, identify population growth, determine public facility and development needs, explore areas where community may lack access to housing, infrastructure, or goods and services, provide basis for zoning and land use decisions, and provide a community driven statement of a positive future that is inclusive of all existing and new residents.


Ms. Donovan and **Mr. Miller** noted the Comprehensive Plan was high level and did not include suggestions or goals for any specific parcels.
