


Public Works & Right of Way

Public Works Overview / Duties

- Buildings & Properties: Anderson Center, Anderson Senior Center, 4 Anderson Township fire stations, Operations Center (Public works, Hamilton County sheriff) Heritage Center, Clark Stone House, Boatsmith, Five Mile Trail restroom, and 6 cemeteries.
- Township Roadways Maintenance (and plowing snow) of over 120 miles of roadway inventory, about 1 million feet of curb line, and over 6 million square feet of sidewalk,
- ► Fleet Maintenance Upkeep of 60 vehicles, including fire, public works and "pool".
- Construction Bidding award and inspection of township funded projects.



Township Roadways

- Maintenance and Inventory
- Philosophy of and Maintenance Strategy
- Crack seal and Cover (3-5years)
- Micro surface overlay the old tar and chip, (8 to 10 years)
- Full Rehabilitation new curbs, sidewalk repair, catch basins and ADA.




Pavement Management

- We contract with an outside Engineering Firm to complete a road assessment survey to rate all 25 MPH streets maintained by the Township.
- We use this survey to plan our future road improvements by street rating.
- The completed survey rates our residential streets from Excellent, Very Good, Good, Fair, Poor and Failing.
- ► There are many factors involved when rating/assessing the road conditions age, substructure, drivability.

Public Right of Way

- Area outside of the roadway that is publicly owned, or in an easement, for the use of the public
 - ▶ Sidewalks
 - Utilities
 - Signage
 - ► Traffic Signals
- ► In Anderson Township
 - State (Ohio Department of Transportation) 19.8 Miles
 Beechmont, US 52, SR 32, I-275
 - County (Hamilton) 73 Miles Clough, Forest, Eight Mile, etc.
 - ► Township (Anderson) 122 Miles Mainly subdivision streets (25 mph)












Public Right of Way Concerns & Review Process

- Contact Anderson Township 688-8400, info@andersontownship.org, Facebook, etc.
- Typical Concerns Speeding, Road Condition, Signage, Pothole, etc.
- Township will route to ODOT or Hamilton County if necessary
- If Township study is warranted, a referral is made to the Sheriff's Office District 5 for review
- ➤ Township staff will also assess this situation, refer to Sheriff's Office input, and Management Team makes recommendation for action by Trustees (when required) or Public Works Department
