

## Organizational Chart




# Public Works (Road & Bridge Fund)

## ▶ Maintain and repair

- ▶ Approximately 123 miles of Township streets and curbs including snow and ice removal
- ▶ Over 90 miles of Township-constructed sidewalks, walkways, trails and bicycle paths
- ▶ Storm sewers and Bridges
- ▶ Six Township cemeteries
  - ▶ Wolfangel on Deaconsbench Court
  - ▶ Asbury on Forest Road
  - ▶ Bridges on Bridges Road
  - ▶ Rose Hill on SR 32
  - ▶ Salem Methodist (Episcopal) Churchyard on Salem and Sutton
  - ▶ Hillcrest on Sutton Road
- ▶ Fleet Maintenance



# Public Safety

- ▶ Fire & Rescue
  - ▶ Emergency medical and advanced life support services
  - ▶ Fire and rescue
  - ▶ Life safety
  - ▶ Disaster planning
- ▶ Sheriff's District 5
  - ▶ Law enforcement
  - ▶ Community policing



# Capital Projects

- ▶ Revenues from the 1994 TIF, for example, have been used:
  - ▶ To purchase fire engines, ambulances, police cruisers, trucks, and snowplows,
  - ▶ Resurface roads, purchase heart monitors and patient cots,
  - ▶ To purchase traffic signal battery back-up units,
  - ▶ To provide quality-of-life amenities including the extensive Anderson Trails network, the Ohio River Trail, Anderson Center, Anderson Lake, and the Five Mile Trail,
  - ▶ To improve and maintain buildings and grounds built or acquired with 1994 TIF dollars,
  - ▶ To purchase the Beech Acres RecPlex, an indoor recreation facility for the community, and
  - ▶ To further economic development
