

**RELEASE, WAIVER OF LIABILITY,  
and  
INDEMNITY/HOLD HARMLESS AGREEMENT  
for  
PARTICIPATION IN ANDERSON TOWNSHIP RIDE AND THRIVE!**

Participant/Guardian does hereby release and hold harmless Anderson Township (County of Hamilton), Ohio, including of its employees, managers, agents, volunteers, representatives, elected officials, and its or their insurers (the “Township” and each, an “Indemnified Party”), from any and all actions, claims, demands, damages and liability for costs related to any injury, loss or damage of whatever nature or description resulting from participation by Participant and/or Participant’s minor child or a minor child for which the signatory hereto is Guardian, in the Anderson Township Ride and THRIVE! event (the “Activity”). As partial consideration for the right to participate in the Activity, Participant or Participant/Guardian does hereby assume for himself/herself, and/or such minor child participating in the Activity, all risks related to such participation. Participant acknowledges that he/she, and/or his/her minor child or the minor child for whom he/she is Guardian, is participating in the Activity voluntarily.

Participant/Guardian gives his/her full permission for the Township and its sponsors of the Activity to use any photographs, videotapes or other recordings of Participant and/or such minor child participating in the Activity that are made during the course of the Activity.

FURTHER, PARTICIPANT, OR GUARDIAN (IF APPLICABLE), AGREES FOR HIMSELF/HERSELF, AND SUCH MINOR CHILD PARTICIPATING IN THE ACTIVITY, TO INDEMNIFY AND HOLD EACH INDEMNIFIED PARTY HARMLESS FROM ALL ACTIONS, CLAIMS, DEMANDS, DAMAGES, AND LIABILITY FOR COSTS RELATED TO, OR ARISING OUT OF ANY INJURY, LOSS, OR DAMAGE OF WHATEVER NATURE OR DESCRIPTION, INCLUDING WITHOUT LIMITATION, DISEASE, SICKNESS OR DEATH RELATING TO PARTICIPATION IN THE ANDERSON TOWNSHIP RIDE AND THRIVE! EVENT.

PARTICIPANT OR GUARDIAN (IF APPLICABLE) FOR HIMSELF/HERSELF, AND SUCH MINOR CHILD PARTICIPATING IN THE ACTIVITY, AGREES THAT THIS RELEASE, WAIVER OF LIABILITY, AND INDEMNITY/HOLD HARMLESS AGREEMENT SHALL BE BINDING UPON HIS/HER, SUCH GUARDIAN’S, AND SUCH MINOR CHILD’S, SUCCESSORS, REPRESENTATIVES, ESTATE, HEIRS AND NEXT OF KIN.
