The Board of Township Trustees met in regular session at 6:30 p.m. this 20th day of November, 2008, with the following members present:

Mr. Jackson introduced the following resolution and moved its passage;

RESOLUTION NO. 08-1120-06

A RESOLUTION REGARDING TRUCK AND VEHICLE LOADS CAUSING LITTER
AND SCATTERING DEBRIS

WHEREAS, this Board has long recognized that litter and debris on roadways can create a hazard that may adversely affect the peace, health, safety, and welfare of persons using roadways within the Township;

NOW, THEREFORE, BE IT RESOLVED by the Board of Township Trustees of Anderson Township (the "Board"), Hamilton County, Ohio, as follows:

SECTION 1. The preamble hereto is incorporated herein and shall for all purposes be construed as integral and operative parts of this resolution.

SECTION 2. That the following regulation is hereby adopted by this Board:

(A) No person shall drive, move, or park any truck or other vehicle within Anderson Township (County of Hamilton), Ohio, unless such vehicle is so constructed and so loaded as to prevent any load, contents, litter or any by-product thereof (i.e., dust, chips or other matter) from being thrown or deposited upon any street, alley, or other public place. No person, being the owner, driver or other person in charge of a vehicle hauling excavated material, coal, coke, construction or building materials, or other materials within the Township shall permit any such material to fall or drop or be blown therefrom onto a street, alley or other public place within the Township. When a vehicle carries trash, sawdust, ashes, cinders, sand, earth, lime, manure or other substance likely to be blown away, the owner, driver, or other person in charge thereof shall, before driving or operating it on any

street, alley or public place, cause such substance or substances to be completely covered with canvas or other substantial covering secured in such manner that the same cannot fall or be blown from such vehicle.

No person shall operate or park any truck or other vehicle, including those used for hauling earth-moving and other equipment, or that has accumulated any mud, dirt, litter or any other debris that is liable to be blown or otherwise dislodged during operation onto any roadway, street, alley or other public place. The owner, driver or person in charge of such truck or vehicle shall, before operating it on any roadway, street, alley or other public place, cause such accumulated mud, dirt, litter or debris to be removed and shall cover such portions of the truck or vehicle with canvas or other substantial covering so that such accumulated material or any by-product thereof cannot be blown or otherwise dislodged during such operation or while parked.

(B) Whoever violates this resolution and regulation is guilty of a minor misdemeanor on a first offense; on a second offense within one year of the first offense, the person is guilty of a misdemeanor of the fourth degree; and on each subsequent offense within one year after the first offense, the person is guilty of a misdemeanor of the third degree.

SECTION 3. That the foregoing regulation shall be posted by the Fiscal Officer in five conspicuous public places in the Township for thirty days before becoming effective, and shall be published in a newspaper of general circulation in the Township for three (3) consecutive weeks.

SECTION 4. This Board hereby finds and determines that all formal actions of this Board concerning and relating to the passage of this resolution were taken in open meetings of this Board, and that all deliberations of this Board and of any of its committees that resulted in such formal actions were taken in meetings open to the public, in compliance with all legal requirements, including (without implied limitation) Section 121.22 of the Revised Code, except as otherwise permitted thereby.
