RESOLUTION NO. 94-0721-01 ADOPTING PARKING REGULATIONS

WHEREAS, the Board of Trustees of Anderson Township, Hamilton County, Ohio, has determined that the public safety and welfare requires that the parking of vehicles on and along the public streets and roads in said Township be controlled and regulated, and

WHEREAS, Ohio Revised Code Section 505.17 authorizes the Board of Township Trustees to adopt such regulations, and

WHEREAS, the Board of Trustees of Anderson Township desires to amend certain parking regulations heretofore adopted,

NOW, THEREFORE BE IT RESOLVED:

- I. Rescinding Prior Resolutions: Certain resolutions pertaining to the parking of vehicles in Anderson Township and heretofore adopted April 20, 1989, and July 10, 1990, (Resolution 90-51) are hereby rescinded, except as they prohibit parking on particular streets or roads.
- II. <u>Definitions</u>: All terms used herein are to be defined as they are defined by Ohio Revised Code Section 4501.01, and as such section may hereinafter be amended.
- III. Prohibition Against Parking of Commercial and Heavy Vehicles,

 Trailers, Watercraft and House Vehicles on Township Streets
 and County Roads in Residential Areas:
- A. No trucks, house vehicles, watercraft, trailers, semitrailers, commercial tractors, dual rear-wheeled vehicles, or any other vehicle exceeding a gross vehicle weight of 9500 pounds, shall be permitted to park or be left standing on or along the township streets or county roads in any residential area other than for the purpose of loading and/or unloading, and only for a reasonable period of time necessary for such purpose. Any such vehicle which is not driven or propelled on land by its own power must be connected to a towing vehicle at all times;
- B. Parking shall be prohibited on either side of any township street or county road nearer than thirty (30) feet to an intersection road;
- C. Parking shall be prohibited on either side of any township street or county road within seventy-five (75) feet of a firehouse driveway.

D. Parking shall be prohibited on either side or both sides of any township street or county road at a place where the Board of Trustees by resolution finds such parking would be hazardous or contrary to the public safety and welfare.

IV. Prohibition Against Parking on Roadways in Shopping Centers:

- A. For purposes of providing access to commercial shopping centers in the township by public safety vehicles and equipment, the following regulations are hereby established as to roadways in shopping centers, provided that accommodation for more than ten (10) motor vehicles is provided:
 - i) There shall be no parking within thirty (30) feet of any fire hydrant upon such property;
 - ii) There shall be no parking within twenty-five (25) feet of any standpipe upon such property;
- iii) There shall be no parking at a place within a designated area adjacent to any building entrance or exit on shopping center property where the Board of Trustees by resolution finds that such parking would be hazardous or contrary to the public safety or welfare.
- V. <u>VIOLATIONS:</u> Whoever violates any regulation or order adopted pursuant to this Resolution is guilty of a minor misdemeanor. Fines levied and collected under this Resolution shall be paid into the township General Revenue Fund.

BE IT FURTHER RESOLVED that these regulations shall become effective after same have been published for three (3) consecutive weeks in a newspaper or general circulation in said township, and thirty (30) days after same have been posted in five (5) conspicuous places in said township by the clerk and when traffic control devices, heretofore erected or hereafter erected by the township Road Superintendent, are prominently displayed and conform to the requirements of Ohio Revised Code section 4511.09.
